The purpose of this position is to coordinate and supervise four (4) Advanced Forester positions and indirectly supervise two (2) Operational Foresters. This staff is for the Returning Hero (RHP) veteran fire crew. This position will assist in coordination Wildland Fires, coordinate and supervise a 10-20 person veteran fire crew on Wildland Fire, planned control burns (Rx) and thinning projects across the state of New Mexico. The position operates as the crew supervisor, managing and transporting fire crew members. Provides training and development of National Wildfire Coordinator Group (NWCG) redcards. Assist in the operations of the Inmate Work Camp as needed. Ensure the application of policies, procedures and laws relating to the use of fire fighters to conduct emergency activities and natural resource projects.

Bachelor's degree in Forestry, Range Management, or Ecology and three (3) years of experience in Forestry, Range Management, Forest Management, Natural Resources, Wildlife Science, Fire Science or Ecology. Any combination of education from an accredited college or university in a related field and/or direct experience in this occupation totaling seven (7) years may substitute for the required education and experience.

This position is designated as safety sensitive within the meaning of Omnibus Transportation Employee Testing Act of 1991 and must abide by all provisions of the Federal Omnibus Transportation Testing Act. Employment is subject to pre-employment and random testing, in accordance with all terms and conditions of federal and state law, rules and regulations in relation to alcohol and/or drug testing. A criminal background investigation will be required, including fingerprints. Must attend a 40 hour Correctional Officers Training Academy.
